ACT ON ACCEPTANCE - WHY OPEN ACCESS MATTERS

Did you know that your open access choices not only affect the visibility of your research but also whether your outputs are eligible for the next REF?

From the 1 April 2016 you will need to **act on acceptance** to make your outputs REF eligible. Articles and conference papers must be placed in an online repository within 3 months of acceptance for publication.

So while you're celebrating your next article being accepted for publication, make sure you <u>deposit your work</u> in the Oxford Research Archive repository. This free service for University of Oxford Researchers allows you to quickly and easily deposit your work via Symplectic Elements.

You deposit, we'll take care of the rest.

Sixty Seconds With...

Carolyn McKee, Deputy Director, Legal Services

In this month's issue, we talk to Carolyn Mckee, Deputy Director of <u>Legal Services</u> about her work for Medical Sciences. Carolyn sits in the Divisional Office most Wednesdays so if you have a question, please pop in or send her an email.

Tell us a little about your role

I'm Deputy Director of <u>Legal Services</u> and lead the IP/Commercial team – that team consists of seven (soon to be eight) solicitors: two are seconded to University subsidiaries and the remaining six cover a broad range of work across the whole University. A lot of our work with the Medical Sciences Division is channelled through Research Services' Joint Research Office where you might encounter us supporting the legal side of more complex transactions. We also tend to be involved in bigger projects where there is a significant commercial dimension. For example, I've advised on creating appropriate legal structures and taken the lead on a range of

joint venture agreements in the past. We also provide direct support to departments undertaking revenue generating activity, buying in services and dealing with legal problems that arise from time to time on the IP/commercial front.

And why is what you and your team do important?

We can help get this right, in order to reduce the chances of something going wrong later and to make it easier to deal with any problems that may arise. Staff in Medical Sciences often work in complex environments where they have to deal with many different requirements – regulatory and legal, funding, ethical, collaborator and third party contractor requirements and we are on hand to provide support through these complex requirements if and when it is needed.

What's currently at the top of your to do list?

At the very top, I am working on an agreement for another division. It's a complicated agreement that I am drafting from scratch. I quite like doing this but it isn't a fast job. It's urgent now because I've been spending a lot of time helping the Medical Sciences Divisional Office with arrangements for the RPIF –funded Precision Medicine Institute, which has been an ongoing project over a number of years.

How did you get to where you are today?

I didn't like working in London when I first trained as a solicitor, so I moved to Devon, and although it was pretty, I found it rather dull. So when I saw a job advertised in 1998 at Oxford University working with Research Services and Isis Innovation, it sounded perfect. My job has changed a lot over the years but I still have a constant stream of interesting projects and get to work with interesting people who make a difference and that's why I keep doing it.

If you weren't working in Legal Services , what would you like to be doing? What keeps you busy outside of work?

I wanted to be a teacher for many years, like my mother, until a careers teacher told me it was a nice job for a girl ... I suppose since my main reason for the choice had centred on the number of Christmas presents my mother received, it may not be a huge loss to the teaching profession!

Outside work I try to organise my three children, one husband and one hamster and take a very long time inexpertly undertaking DIY.

Understanding the opt-out revolution: How it fuels ambition and defines work-life balance

Professor Michelle Ryan, University of Exeter

Women continue to be under-represented in particular roles (such as leadership) and particular sectors (such as surgery or policing), and this has been explained by the fact that women actively choose to opt-out due to an innate lack of ambition and commitment. Michelle will

present a series of studies to contradict such a claim and will demonstrate that women's ambition erodes over time because perceptions of fit and belonging reduce with experience. Importantly, these fit processes have a strong impact of women's perceptions of work-life balance and their willingness to make sacrifices for their careers. Implications for policy and practice will be discussed.

Does your research group need to improve how you manage stock laboratory items? Do you need to register chemical compounds and record assay data? The ChemBio Hub team has created tools to help with these vital tasks.

InventoryReg allows you to keep track of what you have in stock in your lab, including plasmids, antibodies, chemical inventory and consumables. A secure web-based application allows the right people to see where they can find what they need.

ChemReg is a valuable tool for any group needing to collate detailed information about the molecules their laboratory creates or uses. For those generating novel compounds, ChemReg records key characteristics and potential applications. When appropriate, the data can then be deposited in public compound repositories in a simple, supported process.

AssayReg provides a consistent means for researchers to record all relevant data for a given assay. Data can be uploaded one record at a time or from a file of assay or activity data. Dynamic search functionality then allows you to view all relevant data to which you have access. By ensuring well-structured data values, the process of depositing to ChEMBL and PubChem is simplified and getting data ready for publication is also made easier.

SharePoint Upgrade

SharePoint 2010 is a robust, centralised service provided by IT Services to the wider University that runs many business critical applications for departments and colleges. However, since mainstream support for SharePoint 2010 will be ending in October and in order to benefit from the enhanced capabilities of SharePoint 2013, we will be upgrading.

New features include greater flexibility for customisation, a better search facility, the provision of apps – allowing site administrators to add third party features without involvement of the IT Services Nexus team – and better browser compatibility.



Migrations to the new SharePoint service will be starting in January 2016. It is anticipated that SharePoint 2010 sites will remain fully functional; therefore, there will be a phased approach to migrating sites to SharePoint 2013. All SharePoint sites will be closely monitored and migration will be expedited should problems occur, to ensure that users and site owners have minimal disruption to their service. There will be on-line help available for users and the SharePoint project team and the Nexus team will be in touch with site owners (including collection owners) to plan migration of legacy SharePoint 2010 sites to the SharePoint 2013 format.

As well as being a requirement for Wellcome Trust funding, having an ORCID iD now brings extra benefits From August 2015 the Wellcome Trust requires lead applicants to provide an ORCID identifier when submitting a grant application.

An ORCID is a unique researcher identifier you keep throughout your life, wherever you are. ORCIDs are increasingly used by funders and publishers globally to link researchers with their publications and grants.

<u>Open Access Oxford</u> have recently launched the <u>ORCID at Oxford service</u> which enables University of Oxford researchers to create an ORCID iD with verified University affiliation.

And now, with Auto-Update of ORCID profiles, there hasn't been a better time to get your ORCID iD. Auto-Update will automatically update your ORCID profile as soon as any manuscripts or datasets linked to your ORCID iD are published, as long as you follow these <u>simple steps</u> listed on the ORCID blog.

Please sign up for your ORCID through the ORCID at Oxford service, to get a University-affiliated account.

Funding for open access publications arising from finished FP7 projects

The EC has recently launched a pilot fund for open access publications arising from finished FP7 projects. If you are an FP7 project coordinator or a partner and **if you are planning to publish a peer-reviewed article in a fully Open Access journal** after the end of the project you may be eligible for these funds.

This Gold OA Pilot has a \leq 4m budget and will run for a maximum of two years or until such budget is exhausted. Note that it **does not** allow retrospective claims on fees already paid.

The Bodleian Libraries have registered as an institutional coordinator for Oxford applications against the pilot, and are set up on the OpenAIRE website. This allows them to submit publications on behalf of authors. They will do the necessary checking and after submitting the author will be informed by OpenAIRE of progress, publication and payment.

Researchers at the Department of Experimental Psychology University of Oxford are seeking men who stutter for a Transcranial Direct Current Stimulation (tDCS) study.
